Paid Time Off (PTO)

Full-time employees are eligible for Paid Time Off (PTO). The full year balance is awarded at the start of each anniversary year to allow more freedom and flexibility to get away.

Paid Parental Leave

Paid Holidays & Holiday Pay

Innovetive Petcare recognizes six holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

- If your practice is closed on one of these holidays, the holiday falls on a day you are normally scheduled to work, and you are a non-exempt (hourly) employee, you are paid for the holiday.
- If your practice is open on one of these holidays, and you are a nonexempt (hourly) employee who is

working that day, you receive Holiday Pay at the rate of time-and-a-half of your regular hourly compensation.
